

Collins Arcade Terms of Use

By entering or using the Arcade, you agree to comply with these Terms of Use.

1. **Definitions**

For the purposes of these Terms of Use:

- **Arcade** means the Collins Square complimentary arcade experience, including all arcade machines, games, equipment and surrounding areas.
- **Collins Square** means Collins Square, its owners, managers, operators, agents, contractors, employees and security personnel.
- **Game(s)** means the arcade games, machines and related equipment made available within the Arcade from time to time, which may include air hockey, pinball, 3D pong, 2-player Daytona and any other games, machines or equipment added or removed by Collins Square at any time.

2. **Getting started**

- Please follow the instructions on each Game to begin playing.
- Some Games may require pressing “Start” or following on-screen prompts.
- If a Game isn’t working as expected, please notify a Collins Square security member and feel free to start another Game.

3. **Share the experience**

The Arcade is designed for all Collins Square tenants and visitors to enjoy. If others are waiting, please:

- finish your current Game and let the next person have a turn;
- don’t reserve Game machines or play repeated turns during busy periods;
- be courteous and inclusive of others.

4. **Play responsibly**

- Please use all of the equipment as intended.
- Please avoid excessive force, shaking or misuse of the machines.
- Children under the age of 18 years must be supervised by a responsible adult at all times.
- Collins Square Security may refuse, suspend or terminate access to the Arcade at any time, including for inappropriate behaviour, unsafe conduct, misuse of equipment, damage, failure to follow directions or breach of these Terms of Use.

5. **Safety**

- Please be mindful of your surroundings while playing.
- Please keep personal belongings clear of walkways. Collins Square is not responsible for any lost, stolen or damaged personal belongings.
- Participants use the Arcade at their own risk. To the maximum extent permitted by law, Collins Square is not liable for any injury, loss, damage, cost or expense suffered or incurred in connection with a participant’s use of, or inability to use, the Arcade.
- Nothing in these Terms of Use excludes, restricts or modifies any rights or remedies that cannot be excluded, restricted or modified by law.
- Users of the Arcade must comply with all reasonable directions given by Collins Square Security or Collins Square Management in relation to the Arcade. Collins Square Security or Collins Square Management may require any person to stop playing, leave the Arcade or leave Collins Square at any time.
